BBR RETAIL DEALER PRICING-INTEGRITY POLICY

This document sets forth BBR's pricing-integrity policy and conditions of sale for all dealers for the advertising, promotion and sale of BBR Motorsports, Inc. products. This policy is established in order to maintain the integrity of BBR's brand image, premium-product quality reputation, and consistency of BBR pricing in the marketplace.

It is also the intent of this policy to insure that fair and consistent profit margins are maintained on the resale of BBR Products, to the benefit of our qualified distributors and dealers.

The following guidelines are offered as a condition of sale for all BBR manufactured products, BBR private-label products, and/or exclusive BBR distributed products; for all resale purchasers including but not limited to, distributors, dealers, and promotional companies.

SUGGESTED RETAIL PRICING

BBR dealer pricing is published and available upon request to all qualified motorcycle dealers. BBR's "Suggested Retail Pricing" is shown on all dealer price lists. Dealers are required to maintain BBR's "Pricing Integrity Requirement" at all times.

PRICING INTEGRITY REQUIREMENT

Qualified BBR dealers are asked to honor BBR's published "Suggested Retail Pricing" levels on the sale of all products to end-user customers.

ALLOWABLE PROMOTIONAL DISCOUNT PRICING

Qualified BBR dealers must not advertise BBR products at prices reflecting MORE than a 10% discount from BBR's published "Suggested Retail Pricing". Advertising includes, but is not limited to; print ads, promotional flyers, mail-order material, catalogs, and/or the internet. Discounted pricing on BBR products must be in connection with a promotional effort to support the BBR brand and further increase the sale of BBR products.

DEFAULT AND TERMINATION

At no time will BBR allow advertisements or printed retail pricing of BBR products at pricing levels outside the guidelines set forth in this policy. Any dealer which advertises or promotes BBR products below the levels specified above shall be considered in violation of BBR's Pricing Integrity Policy. BBR reserves the right to terminate dealer status, and refuse the sale of BBR products to such companies through direct sale and/or through distribution.
